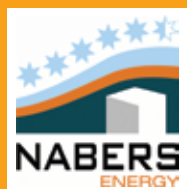
Voltage optimisation

Voltage optimisation is another key solution in reducing energy consumption for the commercial and industrial sector. Voltage optimisation is achieved via an engineered transformer installed within a building which creates maximum energy savings whilst accurately controlling the incoming voltage.

The majority of electrical equipment manufactured today is designed to run at 220 volts. On average the voltage range within Australia is 247 volts, which is 7.4% above Australia's nominal voltage. The transformer we utilise is an ultra-high efficiency design, reducing incoming voltage to 220volts, resulting in energy savings within a building of 12% with additional savings to power hungry sites.

Retail energy solutions

Choosing your energy retailer can have an impact on the cost of your electricity. In some cases this can have an impact of up to 20% on your energy costs. The National Australia Built Environment Rating System (NABERS) is a national rating system that measures the environmental performance of Australian buildings, tenancies and homes.

Put simply, NABERS measures the energy efficiency, water usage, waste management and indoor environment quality of a building or tenancy and its impact on the environment.

It does this by using measured and verified performance information, such as utility bills, and converting them into an easy to understand star rating scale from one to six stars. For example, a 6 star rating demonstrates market-leading performance, while a 1 star rating means the building or tenancy has considerable scope for improvement.
